Highway Maintenance Scheme – Clifton

City of York Council will be carrying out carriageway maintenance works at Clifton commencing on Monday 4th March 2019 for a period of 2 weeks, (weather permitting), the site extents are as shown on the plan on reverse. The works will be carried out between 7.00pm till 1.00am working Monday to Friday only.

The works will consist of resurfacing the road and the reinstatement of all road markings.

In order to carry out these works safely the use of a temporary road closure from the junction of Water Lane to the junction of St Olaves Road will be necessary whilst works are taking place. A clearly signed diversion route will be set out for through traffic. The closure is to ensure that adequate Health and Safety is maintained for both local residents, the travelling public and the Contractor. Site staff will be on hand to advise and assist residents about the access restrictions once the works are ongoing. Your assistance will be much appreciated.

All resident and on street parking will be suspended at these times but any specific access requirements maybe arranged by speaking to the Site Traffic Management Operative who will co-ordinate with residents and business requirements around ongoing construction operations. Any vehicle remaining on the street during the suspension time may be liable to a parking fine and removal costs. **Vehicles with Resident's Parking permits / scratch cards may park in adjacent zones (or nearby Council Car Parks) for the duration of the works, by displaying this letter on the dashboard.**

In addition to the above, we will be carrying out kerbing and drainage works on 25th Feb for a period of a week working 9.15am – 3.45pm. These works will be carried out under local traffic management, will not affect access/egress and the road will be open as normal.

Emergency services will be permitted through the works in any situation. Cyclists will be subject to the same traffic management as other road user vehicles.

As with any construction work, there is likely to be a certain amount of disruption and inconvenience to the public, however the contractor will try at all times to keep any disruption to a minimum.
